SANITARY SECTION

Chairman Walter Newman then introduced the speaker of the evening, Dr. Clarence Tarzwell.

Dr. Tarzwell's talk on Water Quality Control and his views and criticisms of present approaches to standards was very interesting and thought-provoking.

June 5, 1968:—The Annual Outing of the Sanitary Section was held as a joint meeting with the Boston Society of Civil Engineers and included a tour of the water treatment plant, sewage treatment plant, and incinerator in the City of Woonsocket, Rhode Island.

Between the hours of 2:00 p.m. and 5:30 p.m., members visited the above facilities in groups or individually.

The water treatment plant, placed in operation in 1962, has a present capacity of 11.25 mgd with provisions for expansion to 15.0 mgd. Flocculation, sedimentation, and rapid sand filtration is accomplished in annular compartments of single steel structures.

The sewage treatment plant, placed in operation in 1964, provides primary treatment for a design capacity of 10.8 mgd. Treatment units consist of comminutors, aerated grit chambers, primary settling tanks, chlorination contact tank, sludge digestion tanks, and a vacuum filter. Ap-

proximately 3 mgd of primary effluent receives secondary treatment, consisting of conventional activated sludge and final settling, in a split treatment operation, prior to chlorination.

The incinerator, placed in operation in 1960, is designed to burn 160 tons of rubbish per day in two furnaces. At 5:30 p.m., the members re-assembled at the El Dorado Restaurant in Woonsocket, Rhode Island for a social hour and dinner.

At the conclusion of the dinner, Chairman Charles A. Parthum introduced David A. Duncan, Vice President, Metcalf & Eddy, Inc., who spoke on the subject, "Woonsocket Water, Sewage and Incineration Facilities". During Mr. Duncan's talk, he introduced the Superintendents of the three facilities and also introduced Mr. Hedley V. Patterson, City Engineer of the City of Woonsocket, who brought the Boston Society of Civil Engineers Sanitary Section greetings from the City.

Thirty-eight members and guests attended the dinner meeting which was adjourned at about 8:30 p.m.

October 2, 1968:—A meeting of the Sanitary Section was held in the Society Rooms and was called to order at about 7:00 p.m. by Chairman Charles A. Parthum.

Reading of the minutes of the previous meeting (the Annual Outing) was waived.

Chairman Partham introduced Mr. David R. Horsefield of Camp, Dresser & McKee, who presented an interesting talk on "The Proposed Deep Tunnel Plan for the Boston Area."

The plan provides for treatment of excess and storm water flows collected in the combined sewer system, by storage in the tunnel system, pumping to existing plants during periods of reduced flows, and eventual discharge to extended ocean outfalls. The talk was followed by a question and answer period.

HYDRAULICS SECTION
