## Minutes of Meetings

#### ANNUAL MEETING OF THE SECTION

April 13, 1977 - The 129th Annual Meeting of the Boston Society of Civil Engineers (the third meeting of the Boston Society of Civil Engineers Section following the merger of the BSCE with the Massachusetts Section of the ASCE) was held at the M.I.T. Faculty Club in Cambridge. The meeting was called to order at 3:30 p.m. by President Bertram Berger at which time President Berger recognized William R. Gibbs, ASCE President-Elect.

The reading of the minutes of previous meetings was waived, the President noting that these minutes would be published in the Journal. The Secretary, Edward B. The Secretary summarized the Annual Report of the Board of Government in the absence of the treasurer, he also presented the Treasurer's Report.

Horne Fund, Investment, Key Man, Membership, Nominating, Program, Operations Manual, Publications. Journal Editor, Student Chapter, 1979 ASCE Convention, Younger Members, Massachusetts Construction Industry Council Representative and Massachusetts Engineers Council Representative. It was VOTED "that these reports be accepted and placed on file."

Annual Reports of the Technical Groups were requested by the President and were presented: Computer, Construction, Environmental, Geotechnical, Hydraulics, Structural and Transportation. It was VOTED "that these reports be accepted and placed on file." The President stated that all above reports would be published in the Journal.

President Berger made the following announcements:

The Northeastern University Student Chapter has received the Robert Ridgway Award, which is the highest award given for student chapter activities.

The Board of Government has voted to recommend Dean Russel C. Jones as the Zone I candidate for ASCE President-Elect.

The Board of Government has voted to move its offices to 80 Boylston Street, Boston, where it will share quarters with the Consulting Engineers Council of New England and the Massachusetts Society of Professional Engineers.

President Berger then presented his address entitled, "Engineering - Today's Challenge," which will be printed in the *Journal*.

President Berger recognized ASCE Zone I Vice President, Joseph F. Ward.

The meeting was adjourned at 5:15 p.m. to reconvene following dinner.

President Ladd praised President Berger for his achievements during his year in office and briefly outlined his goals for his term in office. He then presented a plaque to retiring President Berger commemorating his year as President.
