#### SECTION INVESTMENTS

## **ANNUAL REPORTS OF COMMITTEES**

## Annual Report of Action Program — Professional Practice Committee 1977-1978

This is the third full year of operation of the committee, and its first year under BSCES's new Operations Manual, which expanded the Committee's scope and responsibilities. The Committee consisted of the following members:

The committee was quite active during the past year in monitoring legislation and governmental policies and practices which affect the engineering profession; also in representing the society at meetings of other societies dealing with matters of specific interest to BSCES; and responding to requests of governmental agencies, other organizations, and private groups for nomination and/or appointment of qualified engineering professionals to serve on various panels, commissions, and committees. Major activities of the Committee were as follows:

#### 1. Review and Favorable Recommendation to the BSCES Board of Government for BSCES Participation in Joint Governmental Affairs Service

This Service, staffed and funded jointly by MSPE, CECNE, BSCES, MSAA, and MALSCE, provides the participating societies with a broad range of services regarding governmental affairs, from basic information gathering to combined lobbying. The service operates out of MSPE headquarters at the Engineering Center and provides the type of continuous and concentrated effort which could not be available on a part-time, volunteer basis. A steering committee, consisting of one member from each society (the Chairman of the Action Program

— Professional Practice Committee in BSCES's case) identifies the specific areas of shared interest and coordinates the activities of the service. Each society has a veto power over any proposed joint activity. The Service commenced in January 1978 and produced the first informational newsletter in February. The first meeting of the steering committee was held in March.

#### 2. Review of Proposed Legislation for Professional Registration of Geologists in Massachusetts

Support of this legislation by BSCES was requested by the Legislation Committee, New England Section, of the Association of Engineering Geologists. The Action Program-Professional Practice Committee and the Geotechnical Group have formed a subcommittee to work closely with the geologists to develop precise wording of legislation which BSCES could accept and support. The subcommittee will be active into 1978-1979. At a House Governmental Regulations Committee hearing on the draft legislation in mid-March (H 2547), a joint Action Program Committee/Geotechnical Group Statement was read to that effect. H 2547 has been referred to a House study committee.

#### 3. Review of Proposed Environmental Protection Agency Regulations for Implementing Recent Amendments to the Water Pollution Control Act

At EPA's request, BSCES, through the joint effort of the Action Program — Professional Practice Committee and the Environmental Group, reviewed and commented on the proposed regulations.

4. Recommendations to BSCES Board of Government on Candidates/Nominees to Serve on Various Public Agencies

The following requests for BSCES suggestions of qualified engineering professionals were processed by the Committee:

- (a) U.S. General Services Administration: Public Advisory Panel (Recommendation: Professor Kenneth Leet, Northeastern University).
- (b) Office of the Governor of Massachusetts: Designer Selection Board (Recommendations, jointly with MSPE and CECNE: Paul Pritzker and Richard Savage).
- (c) Massachusetts Executive Office of Environmental Affairs: Citizens Advisory Committee for Northfield Diversion Project (Recommendation, jointly with Hydraulics Group: Richard DiBuono, U.S. Army Corps of Engineers).
- 5. Active Participation in Other Joint Society Committee

Two committee members are active participants in the joint ASCE/AGC Committee, which has functioned for several years. John Quinn of our Committee is Chairman of the joint committee.

Looking ahead into 1978-1979, the Committee sees itself as getting fully involved with, and guiding for BSCES, the activities of the Joint Governmental Affairs Service. It also sees continued involvement with the geologists' registration proposal, and continued recommendations being made to the Board concerning nominees for specific public/private groups' committees, panels, etc. The Committee is also prepared to handle any other requests for assistance by the Board of Government which may arise.

- 5. That the Annual Meeting be held at Anthony's Pier 4 on April 19, 1978, and that Steve Nevas be engaged as the speaker.

The Board of Government voted to accept these recommendations on November 21, 1977 and accordingly, these items have been implemented as Part I of the Annual Meeting on April 10, 1978 and Part II on the Annual Meeting on April 19, 1978.

#### Annual Report of Disadvantaged Youth Committee, 1977-1978

The committee was composed this year of the following members:

During the past year the Committee continued to pursue its program of placing disadvantaged youths in entry level positions with local engineering firms. In an attempt to accomplish this, a proposal seeking entry level positions (with the potential for educational development and commensurate advancement) was circulated to approximately fifty civil engineering firms in the Boston area during the Spring and early Summer of 1977. The response to this proposal was discouraging, with only two local firms tentatively offering such positions; the result was placement of one individual with Storch Engineers of Brookline.

When this result was discussed at a Board of Government meeting, the members were of the opinion that the cause was unfavorable economic conditions at the time, and urged the committee to continue the program in 1978. In January of 1978 the committee placed a brief description of its program and a request for participation by local firms in the BSCES Newsletter. To date no response has been received. In the year ahead the Committee must re-examine this program and/or its methods of implementation.

A more encouraging aspect of the committee's work over the past year was approval by the Board of Government of its recommendation for allocation of \$400 by BSCES to help sponsor minority high school students in a three-week summer institute, "What is Engineering", sponsored jointly by ASCE's National Committee on Minority Programs and Northeastern University.

Eagleson, MIT, who addressed the subject — "The Annual Water Balance, An Introduction to New and Powerful Methods of Hydrology." Registered attendance was 170, including 22 students. Receipts from nominal fees charged were \$3,040 of which \$204 covered the costs of light refreshments and \$2,836 was transferred to the general funds of the Society at the request of the Board of Government. Direct costs of the lectures — lecturers' honorarium and lecture notes — came to \$2,400 and these were paid from Freeman Fund income. A summary of the lectures will be submitted by Professor Eagleson for publication in the *Journal*.

## Annual Report of History and Heritage Committee, 1977-1978

On September 12, 1977, Minot's Ledge Lighthouse off Cohasset was dedicated as a National Historic Civil Engineering Landmark. In impressive ceremonies at Government Island Park on Cohasset Harbor, the plaque was presented by Mr. William R. Gibbs, then President Elect of ASCE, to the United States Coast Guard which in turn presented it to the Town of Cohasset. The fine cooperation of the Coast Guard and the people of Cohasset made the occasion especially memorable.

On November 17, 1977 we were advised that the Board of Direction of ASCE had designated Boston Naval Shipyard Dry Dock No. I in Charlestown as a National Historic Civil Engineering Landmark. This nomination was made jointly with the Virginia Section and also included Norfolk Naval Shipyard Dry Dock No. 1, the two pioneer dry docks having been designed together and built concurrently. The committee is working with the National Park Service on arrangements for the Charlestown Dry Dock dedication.

On November 30, 1977, the committee submitted to the ASCE National Committee on History and Heritage of American Civil Engineering the nomination of the Tremont Street subway tunnel in Boston as a National Historic Civil Engineering Landmark. We are now awaiting the Committee's recommendation to the Board of Direction on this nomination.

The committee is also working on two future nominations. The committee has been in contact with the Western Massachusetts Branch in regard to the possible nomination of the Borden Baseline. Material has also been gathered for the nomination of Harvard Stadium.

Little progress has been made on the establishment of Massachusetts Historic Civil Engineering Landmarks for sites of local, if not national, importance. This program should be given attention in the coming year. We ask the cooperation of all members in submitting data on local sites to the Committee.
