The Technical Groups also held many other meetings during the year. The Annual Reports of the various Groups were presented at the Annual Meeting of the Section and are published in the Journal.

#### PERMANENT FUND\*

The Permanent Fund was established under the Bylaws, Article 10, and is the recipient of all money received as entrance fees. Under certain circumstances income from the Permanent Fund may be transferred to the Current Fund. The Treasurer's report gives details of the year's transactions.

#### FUNDS ESTABLISHED BY GIFT OR BEQUEST TO THE BOSTON SOCIETY OF CIVIL ENGINEERS\*

JOHN R. FREEMAN FUND. In 1925 the late John R. Freeman, a Past President and Honorary Member of the Boston Society of Civil Engineers, made a gift to the Society of securities which were established as the "John R. Freeman Fund." The income from the Fund is to be particularly devoted to the encouragement of young engineers. Mr. Freeman suggested several uses, such as the payment of expenses for experiments and compilations to be reported before the Society; for underwriting meritorious books or publications pertaining to the hydraulic science or art; or a portion to be devoted to a yearly prize for the most useful paper relating to hydraulics contributed to the Society; or establishing a traveling scholarship every third year open to members of the Society for visiting engineering works, a report of which would be presented to the Society.

EDMUND K. TURNER FUND. In 1916 the Society received a bequest of \$1,000 from Edmund K. Turner, a former member, the income of which is to be used for Library purposes.

\*Details regarding the value and income of these funds are given in the Treasurer's Report.

ALEXIS H. FRENCH FUND. A bequest of \$1,000 was received in 1931 from the late Alexis H. French, A Past President of the Society. The income from the Fund is "to be devoted to the Library of the Society."

CLEMENS HERSCHEL FUND. This Fund was established in 1931 by a bequest of \$1,000 from the late Clemens Herschel, a Past President and Honorary Member of the Society. The income from this Fund "is to be used for the presentation of prizes for papers which have been particularly useful and commendable and worthy of grateful acknowledgement."

DESMOND FITZGERALD FUND. The Desmond Fitzgerald Fund, established in 1910 by a bequest of \$2,000 from the late Desmond Fitzgerald, a Past President and Honorary Member of the Society, provided that the income from this Fund "shall be used for charitable and educational purposes." The Board voted on April 13, 1964 to use the income of this Fund to establish a Boston Society of Civil Engineer's Scholarship in Memory of Desmond Fitzgerald, and that it be given to a student in Civil Engineering at Northeastern University.

Subsequent to September 30, 1979, it was voted to accept the recommendation of the Committee at Northeastern University, that the current scholarship award of \$200 be given to Mark E. Lewis. Presentation was made at the 1980 Student Chapter Night meeting of the Society held at the University of Massachusetts at Amherst on February 26, 1980.

RALPH W. HORNE FUND. This Fund, a bequest of \$3,000, was received June 29, 1964, from the Directors of Fay, Spofford and Thorndike, Inc., the income from which shall be devoted to a prize or certificate to be awarded annually to a BSCE member designated by the Board of Government to have been outstanding in unpaid public service in municipal, state or federal elective or appointed posts; or in philanthropic activity in the public interest.

HOWE-WALKER FUND. This Fund was created by a vote of the Board of Government and combines the Edward R. Howe Fund and the Frank B. Walker Fund. Income from this joint Fund is used to help defray costs of student awards.

WILLIAM P. MORSE FUND. This Fund, a bequest of \$2,000, was received in 1949 from the late William P. Morse, a former member of the Society. No restrictions were placed on the use of this bequest but the recommendation of the Board of Government was "that the Fund be kept intact, and that the income be used for the benefit of the Society and its members." Upon recommendation of the Committee appointed by the President, the Board voted on April 5, 1954 "to appropriate from the income of this Fund a scholarship to be known as the Boston Society of Civil Engineer's Scholarship in memory of William P. Morse, and that it be given to a Civil Engineering student at Tufts University."

Subsequent to September 30, 1979, it was voted to accept the recommendation of the Committee at Tufts University, that the scholarship award of \$200 given to Julia Uffner. Presentation was made at the 1980 Student Chapter Night meeting of the Society held at the University of Massachusetts at Amherst, on February 26, 1980.

THOMAS R. CAMP FUND. This Fund, a bequest of \$10,000, was received January 15, 1971, from the Directors of Camp, Dresser & McKee, Inc., to establish the "Thomas R. Camp Fund", the income to be used to support an annual Thomas R. Camp lecture or lectures on outstanding recent developments or proposed or completed research in the sanitary engineering field. The income from the Fund, over and above that needed to support the annual lecture, should be added to the Fund, but could be used otherwise at the discretion of the Board of Government of the Boston Society of Civil Engineers Section of the American Society of Civil Engineers.

LECTURE FUND. The Lecture Fund was established in 1969 for the purpose of providing money for special lectures sponsored by the Society.

KARL R. KENNISON FUND. This Fund comprised two irrevocable trusts established on behalf of the Society by Karl R. Kennison. These trusts consisted of shares of the Massachusetts Fund, The Massachusetts Company, Inc., trustees. After Mr. Kennison's death net income was to be paid to the Society for a Hydraulics Lecture Fund to be used for various public lectures on this subject, or the Board could withdraw the principal on written demand or make changes in

the use of the Fund as it may determine are warranted. The Investment Committee has recommended to the Board of Government that the funds be consolidated with the principal funds in one location, and this has been done.

# MINUTES OF THE ANNUAL MEETING OF THE SECTION

#### PART I

April 22, 1980 — Part I of the 132nd Annual Meeting of the Boston Society of Civil Engineers (the sixth meeting of the Boston Society of Civil Engineers Section following the merger of the BSCE with the Massachusetts Section of the ASCE) was held at the offices of Camp, Dresser & McKee, Inc. in Boston. The meeting was called to order at 3:00 p.m. by President William S. Zoino.

Executive Director Susan Albert distributed the Annual Report of the Board of Government.

Norman W. Bennett presented the Annual Report of the Treasurer.

In the absence of Secretary Peters, President Zoino called for reports from the following Committees and Technical Groups: Action Program-Professional Practice, Advertising, Annual Meeting, Auditing, Awards, Constitution and Bylaws, Thomas R. Camp Fund, Continuing Education, Disadvantaged Youth, Employment Conditions, Energy, John R. Freeman Fund, History and Heritage, Investment, Key Man, Lecture Series, Membership, Monthly Luncheon, Nominating, Operations Manual, Program, Public Relations, Publications, Social Affairs, Student Affairs; also Technical Groups: Computer, Construction, Environmental, Geotechnical, Hydraulics, Structural, Transportation.

Vice President Frank Perkins moved that all Committee and Technical Group reports be accepted and placed on file. It was seconded and so VOTED.

Charles Ladd noted that this would be the last meeting of the Board of Government to be attended by Bertram Berger as a Past President of the BSCES, and Ladd and the Board commended Berger for his energy, wisdom and leadership.

Albert was instructed to contact Stanley Rossier, Program Chairman for 1981, and advise him that the Board suggested he begin making arrangements now with the Kennedy Library for the 1981 Annual Meeting.

President Zoino presented certificates of appreciation to the retiring Technical Group Chairmen.

President Zoino concluded the meeting's program by presenting his retiring address, which is to be printed in the *Journal*.

#### PART II

April 23, 1980 — Part II of the 1980 BSCE Section Annual Meeting was held at the USS Constitution Museum in Charlestown. President Zoino reconvened the meeting at 7:30 p.m. Following the introduction of the head table guests, President Zoino called upon Secretary Peters to assist in the awarding of prizes and certificates of Life Membership, which were in turn presented by the President.

President Zoino presented to Mrs. Roger F. Gardner a plaque outlining the establishment of the Roger F. Gardner Memorial Scholarship Fund, founded this year in memory of her late husband.

President Zoino read a letter of commendation signed by the Board of Government to Northeastern University's Student Chapter recognizing their outstanding achievement in winning their fourth consecutive Robert Ridgway Student Chapter Award.

Teller Richard M. Simon reported the results of the election of the Nominating Committee Members for two-year terms. They are Richard J. Scranton, Paul A. Taurasi and David E. Thompson.

President Zoino then presented the gavel to incoming President Frank E. Perkins, who then presented a plaque and past president's pin to retiring President Zoino commemorating his year as president. President Perkins then briefly outlined his goals for his term in office.

President Perkins then turned the meeting over to the Program Chairman Edward B. Kinner, who introduced the guest speaker, Julian M. Sobin, Chairman of Sobin Chemicals, Inc., of Boston, which has had long experience in China trade. Mr. Sobin spoke on "Current Perceptions of Sino-U.S. Trade and Other Relations."

The committee continues to be most active in the area of government regulations and legislation. Through participation in the "Design Professional Joint Government Affairs Council", we have been made aware and reacted with other societies on legislation and regulations affecting the Society. The Council has a lobbyist registered with the Massachusetts Secretary of State. The following is a listing of some of the activities on legislation and other matters.

Senate Bill S.1228: Professional registration of government employees without examination. (In oppostion.)

House Bill H.1994: An Act to prevent frivolous malpractice claims against accountants, architects, attorneys, engineers and land surveyors. (In favor.)

House Bill H.2976: An Act to reduce the property tax burden and provide for fairer taxation by closing tax loopholes, increasing state revenues and increasing state assistance to cities and towns, and to limit and control levels of taxation and expenditure. Proposed a 7-1/2% excise tax on a variety of professional services. (In opposition.)

Council aided the Department of Environmental Quality Engineering in the agency's review of the permit process relating to wetlands, hazardous materials, interagency activities and manpower resources.

Opposed policy established by Secretary of Administration and Finance that requires architects, landscape architects and engineers to vie by sealed fee bids for state design contract.

Worked to develop draft legislation on procurement of A/E services in Massachusetts.

Testified at public hearing held by Special Commission Concerning State and County Buildings.

Reviewed legislation and recommendations made by the Special Commission Concerning State and County Buildings.

Initiated a series of "Second Friday Breakfast" with state officials including DEQE Commissioner Cortese, Rep. Beryl Cohen, Secretary Locke and Department of Energy.

City of Boston: Ordinance establishing an Architects and Engineers Qualifications Board; ordinance to be refiled to include selection.

Testified in supports, with comments, on Board of Registration of Professional Engineers and Land Surveyors; proposed changes to rules and regulations regarding professional conduct.

The Committee established liaison with the Boston Chapter of the American Red Cross. The Society will provide expertise in assessing structural damage and flooding potential.

The Committee will make recommendations to the Board of Government for appointments to GSA's Regional Public Advisory Panel and Boston Architectural Center's Advisory Committee on Continuing Education.

The Committee will continue to be most active as a participant on the Design Professionals Joint Government Affairs Council.

# Report of Ad Hoc Energy Committee, 1979-1980

As a possible first step toward organization of a technical group concerned with energy, the Board of Government, in 1979, approved formation of an ad hoc Energy Committee, with the following functions:

- (a) Formulate an energy policy for the BSCE Section.
- (b) Provide a forum to discuss energy needs and how to fill those needs.
- (c) Become an action group to originate and support proper energy legislation.

The committee's initial activity was a dinner meeting at the MIT Faculty Club on May 6, 1980, with a panel discussion on "The MBTA and Future Energy Needs; Is Nuclear Power the Answer?" The speakers were: Robert Foster, Chairman, Massachusetts Bay Transportation

Authority; Senator Michael LoPresti, Co-Chairman of the Massachusetts Senate-House Energy Committee; and Fran Weidenmann, Nuclear Information Officer, Boston Edison Company.

The panelists discussed whether use of the outmoded MBTA power plant should be continued, in view of the fact that Boston Edison can produce power at lower cost, and also discussed the future for nuclear power in this region.

## Report of John R. Freeman Fund Committee, 1979-1980

The Tenth John R. Freeman Memorial Lecture, "The Annual Water Balance" by Peter S. Eagleson, was published in the Spring 1979 *Journal* and, as Proc. Paper 14781, in the August 1979 *Journal of the Hydraulics Division* of the American Society.

The Committee made the January 23, 1980 meeting of the Hydraulics Group possible by paying the expenses of the speaker, Professor John Paul Tullis, who came from Utah State University, Logan, Utah to speak on the subject "Cavitation and Damage in Piping Systems."

The standing Freeman Hydraulics Prize, \$2,500, for an exceptionally useful paper in the field of hydraulic engineering, was announced in the Autumn 1979 *Journal*.

The Committee strongly endorses the serious efforts of the Publications Committee and the Executive Committee to improve the content of the Journal. Toward that objective it recommends that BSCES establish a firm policy of publishing in the Journal in-depth reports, including prints of slides, of all technical meetings. Various devices could be employed for reporting. Most desirably, the speaker himself (or herself) would submit a fully illustrated paper at the time of the talk or shortly thereafter. Recent experience has been most unfortunate in this respect, however. Alternatively, the Technical Group could assign someone to take good notes on the talk, aided, if desired, by a tape recorder, and prepare a writeup, including a selection of the speaker's slides, which would then be reviewed and edited by the Group's Executive Committee and/or the speaker. There being some 34 technical meetings in a typical year, the recommended reporting should result in an additional 100 or so interesting and worthwhile Journal pages per year, which would certainly enhance the Journal's value. The reporting activity in itself would provide a positive stimulus to the technical groups that would carry over to the entire Society. The Society as a whole should encourage this suggested reporting activity by giving all necessary support to the real costs of report presentation - taping, typing, retyping, mailing etc. The Freeman Fund would be a logical source of some of the needed support, and the Committee would welcome a considered proposal in this regard.

## Report of History and Heritage Committee, 1979-1980

While no additional National Historic Civil Engineering Landmarks were designated for Massachusetts since our last report, the year has been a particularly active one. Nominations are now in process for two NHCELs: the Charles River Basin, and the Watertown Arsenal; the latter for the early and important materials testing that was conducted there.

Our nomination of Harvard Stadium for National designation was not accepted. If supplementary documentation on its national significance is not forthcoming, the stadium will be nominated as a Massachusetts Historic Civil Engineering Landmark. Also being processed for local designation are the Borden Base Line, the South Hadley Canal, and the Post truss bridges in Lancaster. Others are in preliminary stages.

Contact with the Museum of Transportation on the preservation of early civil engineering plans continues. It is expected that the development of their new library will start shortly.

Also of interest is contact with the American Society of Metals and the Public Works Historical Society on their historic landmarks programs.

This year the Chairman of your committee is serving as a member of the ASCE Committee on the History and Heritage of American Civil Engineering. This provides BSCE Section with a closer connection with the extensive programs of the National Society in this field of activity.

The coming year should be an active, interesting, and productive one for the Committee. Others wishing to participate would be welcome.

# Report of Membership Committee, 1979-1980

## **Report of Publications Committee**

During the past year, four issues of the BSCE Journal were published as Volume 66, Numbers 1 through 4. There continue to be about 2100 subscribers to the Journal, about 300 of them being from non-members, mostly libraries. A sincere word of thanks is extended to the Journal editor, Ed Keane, for his continued efforts to bring the Journal to print each quarter in a timely and efficient manner.

We continue to experience a serious problem in obtaining technical papers for publication in the Journal. This past year we received only eight papers for review. Of these, seven were reviewed and accepted for publication; the eighth is currently undergoing review. This small number of submitted papers resulted in spite of repeated solicitations to the technical groups and the adoption of a policy that would permit publication of outstanding papers published previously in the form of lecture series notes. It is increasingly clear that if the Journal is to survive as a viable publication in which we can take pride, even more aggressive and imaginative steps must be taken in the future to produce a reservoir of worthy papers. In the absence of successful steps in this regard a serious reappraisal of our publications policies and objectives will be necessary.

The scheduled meetings held by the Structural Group were as follows:

October 3, 1979 — Evening meeting at Green Building, MIT. Dr. John W. Reed, President, Jack R. Benjamin and Associates, Inc., presented the AISC T.R. Higgins Lectureship Award paper entitled "Human Response to Wind-Induced Motion of Buildings". Dr. Reed presented results of surveys of occupants of two tall buildings following wind storms. His lecture presented a method of analyzing and evaluating tall buildings in relation to wind-induced motion discomfort to occupants. Tentative criteria for acceptable motion levels, based on the occupant surveys, were proposed. Sounds recorded during wind-induced motion of several buildings were presented. Attendance, 90.

December 12, 1979 — Evening meeting at Ell Student Center, Northeastern. Four speakers presented a program entitled "New 1979 Massachusetts Building Code - Structural Aspects". The speakers and their topics were:

October 9, 1979 — Carl Condit, Professor of History, Art History, and Urban Affairs, Northwestern University, gave the introductory lecture on "Evolution of Building Structures in the United States".

October 16, 1979 — Mr. Jack R. Janney, formerly President of Wiss, Janney, Elstner and Associates, discussed "Structural Evaluation of Building Structures."

October 23, 1979 — Mr. Maximilian Ferro, Managing Partner, the Preservation Partnership, presented historical and technical aspects of "Wood Structures in the United States".

October 30, 1980 — Professor Clayford Grimm, Civil Engineering Department, University of Texas, discussed historical and engineering aspects of "Masonry and Stone Structures".

November, 6, 1979 — Mr. Howard Newlon, Jr., Associate Head of the Virginia Highway and Transportation Research Council, presented historical and engineering aspects of the evolution of "Concrete Structures in the United States".
